**ELECTRONIC AMENDMENT AND CANCELLATION OF PERMITS FOR CONTROLLED GOODS**

1. We are pleased to inform you that with effect from 15 Nov 97, the TradeNet Electronic Amendment and Cancellation Module will be extended to include TradeNet permits covering import, export and transshipment of controlled goods under the various controlling agencies. This facility will apply to TradeNet permits approved from 15 Nov 97.
2. All joint Customs / TDB permits including pure TDB permits covering controlled goods can now be amended electronically. The fields allowed for electronic amendments are tabulated at the Annex.
3. Electronic cancellation is allowed for all non-payment TradeNet permits covering controlled goods. The conditions for cancellations are that :
  - a. the permit has not expired for more than one day;
  - b. the permit has not been utilized to clear goods;
  - c. the permits has not been returned to Customs Manifests Unit; and
  - d. the goods are not imported or exported from an unmanned place.
4. The electronic amendment and cancellation will be auto approved by the TradeNet System. The facility will greatly facilitate the declaration of permits for controlled goods and it will also increase the timeliness of the delivery of goods to local as well as overseas clients.
