**TRADENET® VERSION 4.1  
INTRODUCTION OF REVISED AHTN CODES AND PRODUCT CODES  
CONTROL OF FISH FRY AND FISH FOR BREEDING AND FARMING**

With the implementation of version upgrade (Version 4.1) in TradeNet® and the introduction of the revised 2012 Asean Harmonized Tariff Nomenclature (AHTN) codes by Singapore Customs on 1 Jan 2012, the Agri-Food and Veterinary Authority (AVA) has made revision to some of the product codes for the following products under its control.

1. Meat
2. Seafood
3. Fresh Fruits & Vegetables
4. Processed Food & Food Appliances
5. Animals & Animal Products
6. Endangered Wildlife Species (CITES)
7. Ornamental Fish
8. Plants & Plant Products

The new lists of product codes for the 2012 AHTN codes for the above products will be posted on AVA website at <http://www.ava.gov.sg/Resources/PrdCodesForTradeNet/> from 1 Dec 2011 to facilitate traders and declaring agents when using the version 4.1 which is available in TradeNet® from 1 Dec 2011 during the 1 month parallel run of both versions (4.0 and 4.1). AVA will remove the current lists of product codes after the parallel run on 31 Dec 2011.

**Control of Fish Fry & Fish for Breeding and Farming**

Please take note that fish fry and fish for breeding & farming which are currently under seafood control are reclassified and will be under the control of ornamental fish section from version 4.1 onwards. The list of AHTN codes affected are as follows:

### Processed Food

We also wish to highlight to you that for processed food and food appliances, as a result of grouping of a few product codes into a single one, some product codes require declaring agents to (a) specify the production process of the product, e.g. for milk products whether they are pasteurised, sterilised or UHT etc, or (b) to specify the exact types/species of the product, e.g. for processed vegetable product, “vegetable, single”, the type of vegetable has to be specified, such as whether it is watercress or cauliflower or spinach etc, in the “product description” field of the permit declaration. We therefore

seek your cooperation to declare appropriately to assist us in monitoring the import of these food products.
