## **CHANGES TO THE STRATEGIC GOODS CONTROL LIST**

### **Updates to the Strategic Goods Control List**

Singapore Customs would like to inform that the new **Strategic Goods (Control) Order 2024** (“SGCO 2024”) has been gazetted on 1 August 2024 and will come into effect from **1 October 2024**. You may access the SGCO 2024 via our website at [www.customs.gov.sg](http://www.customs.gov.sg) > Businesses > Strategic Goods Control > Strategic Goods Control List.

2 The SGCO 2024 brings Singapore’s strategic goods control list up to date with the 2023 Wassenaar Arrangement’s Munition List (“WAML”) and 2023 European Union’s List of Dual-Use Items (“EUDL”). The EUDL contains dual-use items controlled by the four multilateral export control regimes (the Australia Group, the Missile Technology Control Regime, the Nuclear Suppliers Group and the Wassenaar Arrangement).

3 The SGCO 2024 will incorporate revisions as well as editorial amendments for consistency and clarity. A document on the amendments can be found via our website at [www.customs.gov.sg](http://www.customs.gov.sg) > Businesses > Strategic Goods Control > Resources.

### **Amendments to the Strategic Goods (Control) Regulations and Strategic Goods (Control) (Brokering) Order 2019**

4 Amendments will be made to the Strategic Goods (Control) Regulations (“SGCR”) and the Strategic Goods (Control) (Brokering) Order 2019 (“SGCBO”) to update respective references to the new SGCO 2024. There are **no** changes to the scope of the SGCR and SGCBO.

5 The Strategic Goods (Control) (Amendment) Regulations 2024 and Strategic Goods (Control) (Brokering) (Amendment) Order 2024 will come into effect from **1 October 2024**.
